New Business

- David Pugh presents Riverfront Park.
 - Desire for increased activity. David Pugh has a background in City Parks and Rec 14 years. He started at Greenfield lake Park and during that time, he increased public involvement from 15 events to 64 events before Live Nation took over.
- o David Pugh presentation described scheduling.
 - Explained fixed civic events. Due to Live Nation every January 31st.
 - Rentals have a 60-day bump period for concerts. Direct new rentals away from concert season.
 - Hurdles with programing. How much time to schedule, book and market? 3 days per concert to load in, load out.
 - Potential fitness classes
 - Come up with ideas for programs that fit the variable nature of the park.



- Off season requires reservations for events; the best events for on-season are small, non-reservation events
- The City does not do rentals at Greenfield Lake Amphitheater anymore, Live Nation does. (ex: church service)
