WMPO Presentation on Quarter Cent Sales Tax-Presented by Jerod Patterson, CIO

- If approved, Revenue Projections for the Referenda would be 144 million Dollars over 10 years.
- TrailsTransitNHC
- Overview of Bikes & Pedestrians- Provide dedicated bike lanes, sidewalk/intersections/crosswalks & trails (potential funding intersections).
- 3 phases -1st phase Downtown to Archie Blue 2nd phase Wallace Park 3rd phase Forest Hills
 *MPO already has funding designs for phase 1
 - *Also includes Oriole Dr, College Acre, Willshire, Medical Center Dr & Cardinal Dr*
- Wave Transit- Expanding hours of operations, increasing frequency of buses, adding benches/shelter at bus terminals, free youth passes (under 18 years old).
- Rail Realignment- relocating the rail line that crosses outside our busy streets-better connection to bus stops
- Public Transit Related Funding (Great Opportunity for the local community to raise and contribute a
 certain portion of dollars this can allow other Federal agencies to contribute a much larger sum of
 money.

Accessibility for Parks Grant- (need vote of support)-Davina Bell, Recreation Program Manager

- Replace existing playground at Maides Park, universally ground playgrounds with accessibility for all people
- Installation of outdoor fitness equipment



- Replacing shelter behind the gym
- Matching Grant 1-5
- Budgeted at 175k but if awarded significant help would be welcomed and needed
- Letters of support from, Glow Academy, Wilmington Housing Authority, Child Development Ctr, Access to Wilmington, etc.
