Old Business

- By laws update- on May Council Agenda- discussion on draft if needed
- Naming request- Sam Bowens Memorial Field
 - Naming request still ongoing

New Business

- Officer Elections in May.
 - Board to nominate Chair and Vice Chair.
 - Term is one (1) year from May 1- April 30th. Officers can hold multiple terms.
 - Any Board member shall serve for three (3) years. A member may serve two
 (2) consecutive terms. A one (1) year break is required before a member can re-apply.
 - Ingrid Corbi motioned to nominate Terry Smith and Ron Woodruff to continue their positions as Chair and Vice Chair. Franklin Boney seconded the motion and it carried unanimously.
 - The Chair requested that staff solicit additional nominations from the committee ahead of the next meeting.
- Downtown plant beds- North Front St (200-300 block)
 - City Council proposed plant bed barriers downtown.
 - \circ $\;$ The MSD voted to allocate funds for landscape bed fencing.
 - Staff noted that previous landscape bed fencing was damaged by car doors. There's a need to anticipate these kinds of problems.



- In coordination with Wilmington Downtown Inc. and city staff this project would begin in the new budget year, after July 1st, 2024.
- o Laney HS Student Parking Behaviors at Olsen Park
 - Staff presented that students are littering, skipping class, and creating tire skid marks in the parking lot generating complaints from students' parents and park patrons.
 - \circ $\,$ The principal has been receptive to concerns. No comment from the superintendent.
 - Staff proposed installing an entrance gate to control entry in the morning and add towing signage in August before the new school year. This would include communication with the School.
 - Ingrid Corbi motions to install a gate and post signage at Olsen Park. Alexa Fritz seconded the motion and there are seven 'ayes' and one opposed.
