EXECUTIVE SUMMARY

Castle Consulting PLLC has performed a structural analysis on two fabric-clad Aluminum Box-Beam Structures designed by Event Resource Group for the SWIMRVA – NORTHSIDE POOL. These structures are designed and manufactured by Event Resource Group to be capable of withstanding 120 mph wind loads and 20 psf ground snow loads. This analysis considers one fabric configuration: fully clad. This analysis is performed per the ASCE and IBC code, but also considers important engineering criteria that exceed the ASCE 7-16 code. This report details the steps taken to ensure that the structure designed by Event Resource Group meets all requirements set forth by ASCE and IBC for a Risk Category III structure, designed for a wind speed of 120 mph (Exposure C), with a snow load of 20 psf.




Figure 1: SWIMRVA Aluminum Frame Structure #1 (97' x 96' Fabric Hidden)
