

### **Early Warning System**

The Wilmington Police Department Professional Standards Division utilizes a multi-faceted Personnel Early Warning System (IAPro) to track use-of-force incidents, pursuit involvement, citizen complaints, internal investigations, officerinvolved crashes, officer-involved injuries/fatalities, and departmental property losses. When an officer meets or exceeds the threshold for these incidents (set by the dept.), an alert is sent out to the first line supervisor and affected employee.



In 2023, Professional Standards sent out 47 alerts and all were received.
