**PETITION FOR VOLUNTARY NONCONTIGUOUS ANNEXATION**

## PETITION FOR VOLUNTARY NONCONTIGUOUS ANNEXATION

**Submittal Checklist—All items on the checklist must be submitted in order for the petition to be accepted and scheduled for consideration. If any items are not included, the City Clerk will reject the petition.**

\_\_\_\_\_ Annexation petition, signed each property owner within the proposed satellite annexation area

If the deed has multiple owners, such as a husband and wife, then all individuals must sign this petition form. Attach the copy of the deed of each property to the corresponding petition sheet. The original application with original signatures must be submitted to the City Clerk and a duplicate copy submitted to the Planning Division. If the property is owned by a corporation or entity other than a private individual, a responsible corporate officer must sign as petitioner with an attestation by a second corporate officer and the corporate seal affixed.

\_\_\_\_\_ Meets and bounds description, APPROVED BY CITY ENGINEER. The petition must be signed by the City Engineer prior to submitting to the City Clerk.

\_\_\_\_\_ Map showing the area proposed for annexation with relation to the primary city limits; this map must include the distance of the proposed satellite annexation area to the primary city limits and from what point it is calculated.

If the proposed annexation is within close proximity to a city other than Wilmington, the map must also show the distance of the proposed satellite to the other city's limits.

\_\_\_\_\_ Annexation petition fee and zoning petition fee

\_\_\_\_\_ List of parcels to be annexed, including the tax parcel number, property owner, and property owner mailing address for each parcel

- An invoice will be emailed for the mailing fee at a cost of \$0.85 per notice. Note that this cost will include two mailings, one mailing notifying property owners for planning commission review and a second mailing notifying property owners of city council review. Payment must be made within 5 business days of the invoice

\_\_\_\_\_ A current to-scale copy of a New Hanover County tax map highlighting the petitioned property and the current city limits.

\_\_\_\_\_ Map to be recorded with the New Hanover County Register of Deeds
